

Justice Harriet O'Neill, VISION More is required of public officials than slogans and handshakes and press releases. More is required. We must hold ourselves strictly accountable. We must provide the people with a vision of the future. - Barbara Jordan

The **VISION** Award recognizes a leader or organization committed to ending powerbased personal violence in Texas.

This year we are pleased to honor Justice Harriet O'Neill. Justice O'Neill retired from the Supreme Court of Texas in June 2010 after nearly 12 years of service. As an active member of the Texas Access to Justice Commission, she played a significant role in helping to expand access and reduce barriers to justice in civil legal matters for the poor. One of her key initiatives was the development of multi-lingual, selfhelp legal tools for victims of domestic violence. Justice O'Neill spearheaded the Supreme Court's creation of, and Chaired, the Permanent Judicial Commission for Children, Youth and Families, whose mission is to improve the safety, permanency and well-being of children caught up in the child-protection system. While on the Court, she was appointed by the United States Attorney General to the National Advisory Council on Violence Against Women. For all of these reasons, we are thrilled to honor a true visionary leader, Justice Harriet O'Neill.

Valerie and Morghan, COURAGE

I learned that courage was not the absence of fear, but the triumph over it. - Nelson Mandela

The **COURAGE** Award recognizes a former client who has demonstrated the courage to leave their abuser and create a healthy, productive, and secure life.

This year The Project honors both Valerie and her daughter Morgan whose journeys illustrate the power that legal solutions have in ending unimaginable violence. Like any mother Valerie was worried when Morghan's behavior started to change, but never imagined it was because her own husband had been hurting her daughter. Though devastated Valerie sprang into action and called the police and protected her family. For free, The Project got Valerie a divorce so she would no longer be tied to her daughter's abuser, a protective order for Morghan so that he couldn't retaliate against her for telling, and a termination of his parental rights so co-parenting would not be required in the future.

Texas Advocacy Project is committed to achieving its vision that *All Texans should live safely in hope, not fear.* Our legal services assist thousands of victims of domestic and dating violence, sexual assault, and stalking each year, including many children who are directly in harm's way. The following is a brief overview of Texas Advocacy Project's services:

LEGAL LINE

Attorneys offer free legal advice regarding protective orders, divorce, child custody and visitation, child support, grandparents' rights and other issues related to domestic and dating violence, sexual assault, and stalking.

DIRECT SERVICES/IMPACT LITIGATION

The Project provides direct legal services to some clients when their cases are too complicated to navigate alone. Occasionally we find that for some the barrier to justice is too high. When this occurs we file impact litigation to ensure courts are fairly serving survivors.

ASSISTED *PRO SE*

This service supports clients in representing themselves. Attorneys are able to provide free, individualized legal assistance by preparing customized legal documents, offering ongoing legal advice, and giving detailed instructions to survivors about how to represent themselves in any hearing.

EMERGENCY PROTECTIVE ORDERS

This service is only offered in Travis County; however, training is available statewide on best practices regarding Magistrates Order for Emergency Protection. Attorneys work with local law enforcement and the judiciary to assist victims of power-based abuse in the hours immediately following an arrest. Attorneys discuss legal options, including options of protective orders and safety planning.

SURVIVOR SERVICES

This service provides the necessary tools for long-term safety and starting a new life including economic abuse services. Some of the tools we provide are safety plans, shelter location, and referrals for help with mental, physical, and emotional healing. Our Survivor Services team can also help with accessing Crime Victims' Compensation (CVC) and Texas Victim Information & Notification Everyday (VINE) services and registration.

OUTREACH

Everyone deserves safety and has the right to live free from fear. The process may feel overwhelming and scary, but Texas Advocacy Project is with you each step of the way. We engage in targeted outreach to communities who may experience power-based abuses but who do not self-identify as survivors or have the know-how to navigate the civil justice system. These groups include teenagers, university students and staff, those with language barriers, hospital staff, and others.
